STEM TOYS FOR SPECIAL  
NEEDS STUDENTS

Chief Academic Officer, Alesia Flye introduced Mark Muzzin, STEM Consultant and two IAM students who provided an update on the work they began in 2021 with their IAM robotics team to provide summer camps for students. The program has since grown and year after year the IAM students continue to provide more experiences for younger students. In 2025 they also set off on a project that impacted over 180 special needs students where 147 toys were made, wrapped

and delivered around the holiday season.

DHH CAMPS

Assistant Superintendent for Special Education and Student Services, Justin Michalak, introduced our Deaf and Hard of Hearing staff who provided an update on the work that they do. The group services over 296 students in all districts and center programs throughout the county. Over the past summer they provided a camp for deaf and hard of hearing students and also created a number of family events to provide opportunities for students to meet up with like kids to learn about hearing loss.
