ELECTION MEETING	The MISD Board Election meeting began at 4:00 p.m. in Room 201 A/B at the Educational Service Center.
CALL TO ORDER	The meeting was called to order by President Genest at 4:00 p.m. President Genest appointed Edward V. Farley as Acting Secretary (in Brian White's absence).
	Members Present: Theresa Genest, Donald Hubler, Edward Farley and Michael A. Schulte.
	Administration Present: Superintendent Michael DeVault, Assistant Superintendent Rosetta Mullen, Assistant Superintendent David Rilley (Analisa Collins as recording secretary).
PRESENTATION OF DOCUMENTS	Mrs. Mullen reviewed the election documentation and announced that she has received the filing notice and election ballots from the Macomb County Clerk's Office. Edward V. Farley, Donald R. Hubler and Ian Colin McCain are the three (3) eligible candidates for the 2025 MISD School Board Election. This election meeting has been duly noted and meets the requirements of the Open Meetings Act. Mrs. Mullen advised the Board that Mr. White sent out statutory notice as required by the Revised School Code of this meeting to all Board of Education Secretaries to each of the 21 districts. Mr. White also sent a reminder as a courtesy.
APPOINTMENT OF AND INSTRUCTION TO ELECTION CANVASSERS	Mrs. Genest instructed that at the time the votes are cast, Mr. Farley, assisted by the canvassers, shall have available a copy of the local district's resolution, for each delegate to review. The resolution identifies the candidates that each local district supports (at least on the first ballot); and its designated representative.

In the event the district's designated representative fails to vote in favor of the individual(s) identified in its resolution, then such non-conforming vote shall not be counted in the election results.

Rosetta Mullen and David Rilley of Macomb Intermediate School District were appointed election canvassers by President Genest.

Mr. Farley presented the ballot box and began distributing ballots and recording the delegates representing each district.

Mrs. Genest asked the canvassers to count the votes. Edward V. Farley and Donald R. Hubler were declared the winners with 16 votes cast for Edward V. Farley, 17 votes cast for Donald R. Hubler and 1 vote case for Ian Colin McCain out of 17 districts.

Mrs. Genest thanked Mrs. Mullen and Mr. Rilley for their assistance as election canvassers.

Mr. Hubler moved, supported by Mr. Farley, to adjourn.

The meeting was adjourned at 7:04 p.m.
